This website is committed to protecting your privacy and we comply with the data protection laws applicable to the USA. This Privacy Policy outlines how your personal information is collected, used, and shared when visiting our website www.bravosconstruction.com.

WHAT INFORMATION DO WE COLLECT?

When you request more information from a company that appears on our site, you are asked to fill out a request form or our advertising form. We will ask for your name, email address, mailing address, phone number, and what capital you may have to invest. The details submitted in this form will be stored on our server in the USA and you will become a registered user of this website. So that you are aware as to who we will be sharing your information with, the name of the company you requested information about will show up at the bottom of the request form.

CONSENT

How do you get my consent?

HOW DO WE USE YOUR INFORMATION?
